IN 2024, CARE FOR THE HOMELESS (CFH) PROVIDED 43,000 INTEGRATED PRIMARY AND BEHAVIORAL HEALTH VISITS TO MORE THAN 13,000 HOMELESS AND UNSTABLY HOUSED MEN, WOMEN, AND CHILDREN AT 22 HEALTH CENTERS SERVING ALL 5 BOROUGHES OF NEW YORK CITY. IN ADDITION, CFH OPERATED 757 TRANSITIONAL HOUSING BEDS (SHELTERS AND SAFE HAVENS) AT 5 FACILITIES IN NYC DURING 2024. 198 RESIDENTS WERE PLACED INTO PERMANENT HOUSING FROM THESE 5 FACILITIES. CFH ALSO SPONSORED TWO POLICY SEMINARS DURING 2024 THAT CONTRIBUTED TO THE PUBLIC DIALOG ABOUT SOLUTIONS TO HOMELESSNESS.
